THIS AGREEMENT, made this day of
One Thousand Nine Hundred Seventy-four between the COUNTY OF
BURLINGTON acting through its BOARD OF CHOSEN FREEHOLDERS OF THE
COUNTY OF BURLINGTON, hereinafter called the County and the STATE
OF NEW JERSEY acting through its Commissioner of Transportation,
hereinafter called the State;

WHEREAS, in the construction of Route 130 Section 10E,
the State constructed the Route 130 northbound Burlington by-pass;
and

WHEREAS, the existing Route 130 was made one way south-
bound; and

WHEREAS, the said construction included new intersections
at County Route 670 (Jacksonville Road) and County Route 541
(High Street); and

WHEREAS, the legal and maintenance responsibilities at
said intersections of County roads with Route 130 have never been
officially established; and

WHEREAS, in order to avoid the possibility of any future
disagreement between the State and the County concerning these
roads, it is impelling upon the County and the State to apportion
the jurisdiction, control and maintenance of these facilities in
an equitable manner.

NOW, THEREFORE, this agreement witnesseth that for and
in consideration of the mutual covenants contained herein, the
County and the State agree as follows:

FIRST, the County agrees to:

Assume or retain jurisdiction, control and maintenance in
those areas as shown with single-line hatching on a map entitled;
"NEW JERSEY DEPARTMENT OF TRANSPORTATION, ROUTE 130, SECTION 10E,
JURISDICTIONAL LIMIT MAP, FROM LOGAN STREET TO LINCOLN AVENUE,
CITY OF BURLINGTON, BURLINGTON COUNTY, SCALE 1" = 200', FEBRUARY
1974," appended hereto and made a part hereof.

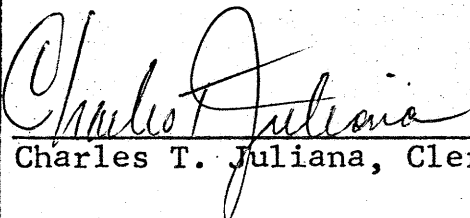
SECOND, the State agrees to:

Assume or retain jurisdiction, control and maintenance in those areas shown shaded (not hatched in any manner) on the said map within the right of way of Route 130.

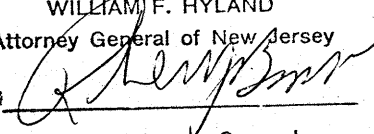
