

THIS AGREEMENT, made this day of
One Thousand Nine Hundred and Ninety, between the COUNTY OF
BURLINGTON, a body politic and corporate of the State of New Jersey,
acting through its BOARD OF CHOSEN FREEHOLDERS, hereinafter referred
to as the "County", and the STATE OF NEW JERSEY, acting through its
Commissioner of Transportation, hereinafter referred to as the
"State", witnesseth that:

WHEREAS, the State plans to make improvements to Route
U.S. 130 in the County; and

WHEREAS, these improvements will include the area of Route
U.S. 130 and Chester Avenue; and

WHEREAS, Chester Avenue is a County highway; and

WHEREAS, there presently exists a jurisdictional agreement
between the County and the State dated June 28, 1972, which portions
thereof address the above location; and

WHEREAS, it is the intention of the parties hereto that
upon completion of construction that portion of the above agreement
dated June 28, 1972 shall be superseded; and

WHEREAS, in order to prevent future legal or maintenance
problems in this area, it is necessary that the County and the State
apportion the jurisdiction for highway maintenance and control in an
equitable manner pursuant to N.J.S.A.27:7-1 et seq.

NOW, THEREFORE, in consideration of the mutual covenants
contained herein, the County and the State agree as follows:

FIRST, the County agrees to:

Assume or retain jurisdiction for highway maintenance and control,
upon completion of construction, in that area as shown with single
line hatching on sheet 1 of 3 total sheets of a map entitled "NEW
JERSEY DEPARTMENT OF TRANSPORTATION, ROUTE U.S. 130 SECTION 8J & 9L,
JURISDICTIONAL LIMIT MAP, FROM NORTH OF HARTFORD ROAD TO SOUTH OF
JACKSON STREET, TOWNSHIPS OF DELRAN AND CINNAMINSON, COUNTY OF
BURLINGTON, SCALE: AS INDICATED," which map is appended hereto and
made a part hereof

SECOND, the State agrees to:

Assume or retain jurisdiction for highway maintenance and control, upon completion of construction, in those areas shown shaded on the said map.

THIRD, both the County and the State agree that:

- (a) Nothing contained in this agreement shall be construed to affect the legal and/or maintenance responsibilities for any traffic signal systems, overhead lighting, or other electrical facilities involved in the subject roadway areas.
- (b) Upon completion of construction, this agreement supersedes the above described portion of the previously executed jurisdictional agreement dated June 28, 1972.
- (c) This agreement will not be binding until executed by the Commissioner of Transportation or the Commissioner's designee.

IN WITNESS WHEREOF, the parties have signed, sealed and attested to this agreement.
