THIS AGREEMENT, made this 23 day of Sptember

One Thousand Nine Hundred Seventy-seven, between the COUNTY OF

BURLINGTON acting through its BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY

OF BURLINGTON, hereinafter called the County, and the STATE OF NEW

JERSEY, acting through its Commissioner of Transportation, hereinafter

called the State, witnesseth that:

WHEREAS, the jurisdictional limits of County Road Nos. 537, 669, 630, 621 and 530 intersecting with Route U.S. 206 has never been established; and

WHEREAS, the State has recently resurfaced Route U.S. 206 in this area; and

WHEREAS, in order to avoid future legal and maintenance problems in this area, it is necessary that the County and the State apportion the jurisdiction, control and maintenance of these facilities in an equitable manner.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the County and the State agree as follows:

FIRST, the County agrees to:

- (a) Assume or retain jurisdiction and control in those areas of County roads as shown with single line hatching on a map entitled "NEW JERSEY DEPARTMENT OF TRANSPORTATION, ROUTE U.S. 206, SECTION 7A & 6A, JURISDICTIONAL LIMIT MAP, FROM CHAMBERS CORNER TO SOUTH OF ROUTE 38, TOWNSHIPS OF SPRINGFIELD, PEMBERTON, EASTHAMPTON AND SOUTHAMPTON, COUNTY OF BURLINGTON, SCALE: 1" = 200', APRIL 1977," appended hereto and made a part hereof.
- (b) Assume or retain complete responsibility for all maintenance in that area specified in part FIRST subparagraph (a) above.

SECOND, the State agrees to:

- (a) Assume or retain jurisdiction and control in those areas shown shaded (not hatched in any manner) on said map within the right of way of Route 206.
- (b) Assume or retain complete responsibility for all maintenance in those areas specified in part SECOND subparagraph (a) above.

IN WITNESS WHEREOF, the County has had this instrument signed and attested, and the State has caused the same to be done on its part. .
