THIS AGREEMENT, made this 3th day of Systember One Thousand Nine Hundred Seventy-seven, between the COUNTY OF BURLINGTON, acting through its BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF BURLINGTON, hereinafter called the County, and the STATE OF NEW JERSEY, acting through its Commissioner of Transportation, hereinafter called the State, witnesseth that:

WHEREAS, because of heavy volume of truck traffic generated on a portion of Old York Road that is now acting as part of a connector from Route 295 to Route 206 and the New Jersey Turnpike interchange at Route 206 and Old York Road, the State wishes to take over jurisdiction, control and maintenance of Old York Road in this area; and

WHEREAS, the New Jersey Turnpike Authority holds title to a portion of Old York Road that was subsequently turned over to the County for jurisdictional purposes; and

WHEREAS, the title of the roadbed will remain with the Authority, and only the responsibilities assigned to the County by the Authority will be assumed by the State by means of this Agreement; and

WHEREAS, there is a current jurisdictional agreement with the Township of Bordentown by which the State took over Rising Sun Square Road from Route 295 to Old York Road.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the County and the State agree as follows:

FIRST, the County agrees to:

(a) Relinquish jurisdiction, control and maintenance of that portion of Old York Road to the State, that presently serves as a connector between Route 295 and Route 206, as shown with shading on a map entitled "NEW JERSEY DEPARTMENT OF TRANSPORTATION, ROUTE 295, SECTION

- 5B, JURISDICTIONAL LIMIT MAP, RISING SUN SQUARE ROAD AND OLD YORK ROAD, TOWNSHIP OF BORDENTOWN, COUNTY OF BURLINGTON, SCALE: 1" = 200', JANUARY 1977," appended hereto and made a part hereof.
- (b) Enter into a new agreement with the State to resume jurisdiction, control and maintenance of that portion of Old York Road stated in part FIRST subparagraph (a) above, if and when the Township of Bordentown resumes jurisdiction, control and maintenance of that portion of Rising Sun Square Road from Route 295 to Old York Road.

SECOND, the State agrees to:

- (a) Assume or retain jurisdiction and control in those areas shown shaded (not hatched in any manner) on said map.
- (b) Assume or retain complete responsibility for all maintenance in those areas specified in part SECOND subparagraph (a) above.
- (c) Enter into a new agreement with the County to relinquish jurisdiction, control and maintenance of that portion of Old York Road stated in part FIRST subparagraph (a) above should the Township resume jurisdiction, control and maintenance of Rising Sun Square Road from Route 295 to Route 206 at some future date.

IN WITNESS WHEREOF, the County has had this instrument signed and attested, and the State has caused the same to be done on its part.
