THIS AGREEMENT, made this 13 th day of January One Thousand Nine Hundred Sixty-nine between the BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF BURLINGTON, hereinafter called the County and the STATE OF NEW JERSEY acting through its Commissioner of Transportation, hereinafter called the State;

WHEREAS, in the construction of Route 38 (1953) Sections 1F and 2C the State has constructed a major interchange with Routes 38, 41 (Kings Highway) and Route 73; and

WHEREAS, the said interchange will utilize and entail improvement to a portion of the said (Kings Highway); and

WHEREAS, it is impelling upon the County and the State to apportion the jurisdiction, control and maintenance of this improved facility in an equitable manner.

NOW, THEREFORE, this agreement witnesseth that for and in consideration of the mutual covenants contained herein, the County and the State agree as follows:

FIRST, the County agrees to:

- (a) Assume or retain jurisdiction and control in that area improved as shown with single line hatching on a map entitled: "NEW JERSEY DEPARTMENT OF TRANSPORTATION, ROUTE 38 (1953) SECTIONS 1F & 2C, JURISDICTIONAL LIMIT MAP, INTERCHANGE AT ROUTES 38, 41 and 73, TOWNSHIPS OF CHERRY HILL & MAPLE SHADE, COUNTIES OF BURLINGTON & CAMDEN, SCALE: 1" = 200', APRIL, 1967".
- (b) Perform minor maintenance including ice control and snow removal functions in that area specified in (a) above until the year ending 1972, after which date the County will perform complete maintenance functions.
- (c) Notify the State of any major maintenance obviously needed in that area specified in (a) above prior to the year ending 1972.

SECOND, the State agrees to:

- (a) Assume jurisdiction, control and maintenance in those areas shown plain (not hatched nor shaded in any manner) on the said map within the right of way of Routes 38, 41 and 73.
- (b) Perform major maintenance functions in that area specified in part FIRST item (a) either on its own initiative or upon notice from the County until the year ending 1972, after which date all maintenance will be performed by the County.

SECOND, the State agrees to:

Assume jurisdiction, control and maintenance in those improved areas shown plain (not hatched in any manner) on the aforesaid map.
